A VIRTUAL CONFERENCE WAS ARRANGED BY CONTRACTING WITH THE UW PYLE CENTER WITH 416 REGISTRANTS. ATTENDEES HAD THE OPPORTUNITY TO "ATTEND" TEN SEPARATE SEMINARS, TRAININGS, AND INFORMATION SESSIONS. ADDITIONALLY, OUR BYLAW-MANDATED BOARD MEETINGS AND ANNUAL MEMBERSHIP MEETING WERE EFFICIENTLY HELD. WE WERE THRILLED TO WELCOME JIM STAUDACHER, THE FIRST PERSON TO HIKE THE TRAIL IN 1979, AS OUR KEYNOTE SPEAKER.

IATA'S YOUTH EDUCATION PROGRAM, SAUNTERS, HAD INCLUDED 22 SCHOOL DISTRICTS ACROSS THE STATE WITH 23 PROGRAM OPTIONS PRIOR TO THE PANDEMIC. ONLY A COUPLE WERE HELD BEFORE CLOSINGS IMPACTED OUR OFFICES

4b (Code:) (Expenses \$ 470,426. including grants of \$ 0.) (Revenue \$ 0.) LANDS - IATA PROTECTED NINE PROPERTIES IN 2020 THAT PROTECT APPROXIMATELY 3.5 MILES OF TRAIL AND 270 ACRES. PROPERTIES WERE PROTECTED IN BOTH FEE AND EASEMENT. ALL THESE LANDS WILL HOST A VARIETY OF PUBLIC RECREATIONAL OPPORTUNITIES THAT INCLUDE THE ICE AGE NATIONAL SCENIC TRAIL.

SEVENTY-SIX TRAIL STRUCTURES INCLUDING 1,277' OF WOODEN STRUCTURES AND 260' OF ROCK WALLS AND ONE NEW DISPERSED CAMPING AREA WERE BUILT. IATA'S EIGHT MOBILE SKILLS CREW PROGRAMS GENERATED ALMOST 40% OF ALL VOLUNTEER HOURS REPORTED BY THE IATA. TOTAL VOLUNTEERS FOR THE YEAR WERE 1,499, CONTRIBUTING 53,297 HOURS. IATA MEMBERSHIP GREW TO A RECORD
