MULTIPLE WORKSHOP TRACKS WERE SCHEDULED OVER THREE DAYS. ATTENDEES PARTICIPATED IN TEN SEPARATE SEMINARS, TRAININGS, AND INFORMATION SESSIONS. ADDITIONALLY, OUR BYLAW-MANDATED BOARD MEETINGS AND ANNUAL MEMBERSHIP MEETING WERE EFFICIENTLY HELD. WE WERE THRILLED TO WELCOME JENNIFER PHARR-DAVIS AN INTERNATIONALLY RECOGNIZED RECORD-BREAKING LONG-DISTANCE HIKER AS OUR KEYNOTE SPEAKER.

IATA'S YOUTH EDUCATION PROGRAM, SAUNTERS, INCLUDED 30 SCHOOL DISTRICTS ACROSS THE STATE WITH OVER 70 PROGRAM OPTIONS. A GRANT FROM THE

IN ADDITION TO DIVERSE TRAIL CONSTRUCTION, MAINTENANCE, STEWARDSHIP, AND OUTREACH AND EDUCATIONAL ACTIVITIES THAT OCCUR ON AN ONGOING BASIS, IATA ADDED 6+ MILES OF SUSTAINABLE TRAIL TREAD AND BROUGHT AN ADDITIONAL 25 MILES UP TO NATIONAL PARK SERVICE STANDARDS.
